Ms. Ochieng' also advises clients on various issues and has vast experience in negotiations, drafting, reviewing and reviewing of contracts.



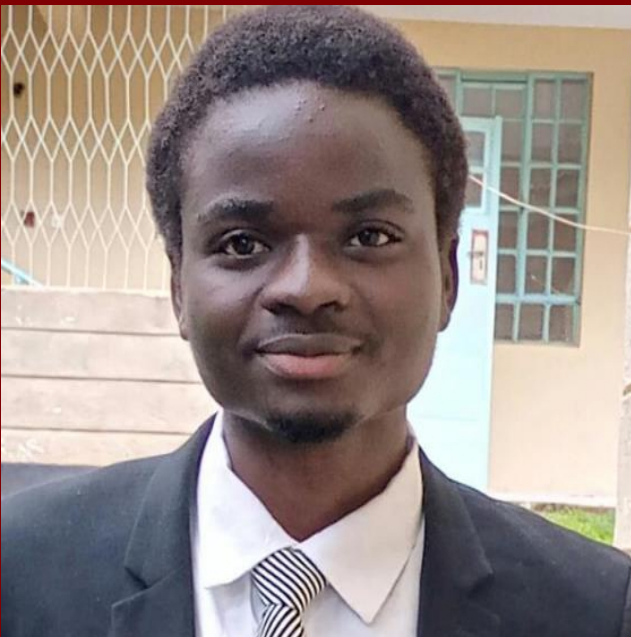
